**Sub. : Closure for Trading Window.**

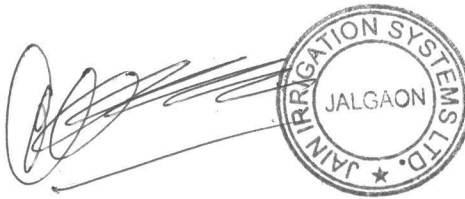
