**"RESOLVED** subject to the applicable provisions of the Companies Act, 2013, including any statutory modification or re-enactment thereof, for the time being in force, the applicable Rules, Guidelines, Regulations, Notifications and Circulars, Listing Agreements entered into by the Company with each of the Stock Exchanges where the equity shares of the Company are listed, and the Foreign Exchange Management Act, 1999, and as amended from time to time and the rules and regulations made thereunder, and the Memorandum and Articles of Association of the Company, the consent of the Securities Issuance Committee-2 of the Company be and is hereby accorded to issue and allot to Mandala Rose Co-Investment Limited ("**Investor**"), 36,200,000 Compulsorily Convertible Debentures ("**Debentures**") at a price of INR 80 (Rupees Eighty) per Debenture, for an aggregate consideration of approximately INR 2896 million, on the terms and conditions agreed with the Investor, which are as attached at **Annexure I**, hereto.
